SUMMARY OF INFORMATION:

Forsyth County has been awarded by the N.C. Department of Health and Human Services Aging and Adult Services Division, \$3,275 for the Operation Fan Heat Relief (OFHR) Program for the service period of May 1, 2020, through October 31, 2020. These funds provide for the purchase of fans to support the summer program intended to provide a more comfortable living environment and reduce heat related illnesses for older adults and adults with disabilities. Eligibility will be determined by Forsyth County Department of Social Services (FCDSS), Adult Services Social Workers for fan distribution. These funds are provided by contributions through the Division of Aging and Adult Services to Area Agencies on Aging by Duke Energy Progress, Duke Energy Carolinas and Dominion Resources. There is no County money involved.

EXPLANATION:
